WHEREAS, it is the desire of the undersigned owners of at least three quarters (3/4) of the lots in Tierra Viva Subdivision to amend the Declaration of Covenants, Conditions and Restrictions for Tierra Viva Subdivision, filed for record in the Office of the County Clerk of Bernalillo County on September 23, 1997 in Book 9726 at pages 2457-2494.

NOW, THEREFORE, Article 3 is amended to add Section 3.01. 1 to read as follows:

Section 3.01.1 Permitted uses: Notwithstanding the provisions of Section 3.01 "Permitted Uses of Property Within the Subdivision", nothing herein prevents any home occupation, provided:

- (a) The activity is clearly incidental and secondary to use of the premises for a dwelling.
- Only members of the residing family are employed. (b)
- (c) No stock in trade is manufactured, displayed, or sold on the premises, except a small stock of art objects and custom sewing created by a resident of the dwelling is allowed.
- All business activities are conducted entirely indoors. (d)
- No more than 25% of the floor area of the dwelling is devoted to the home (e) occupation. No more than 5% of the floor area of the dwelling is devoted to storing stock in trade.
- There is no external evidence of the activity, such as commercial vehicles, (f) inordinate vehicular traffic, outside storage, noise, dust, odors, noxious fumes, or other nuisances emitted from the premises.
- Health care (including physicians, nursing homes, massage and the like) (g) shall not be considered a permissive home occupation.
- One related on-premise sign is permitted, provided: (h)
 - 1. It does not exceed one square foot in area.
 - It is a non-illuminated wall sign. 2.

All other provisions of the Declaration shall remain the same.

This second amendment may be executed in counterparts, each of which shall be considered an original.
